Employment Notice **Guadalupe County Fire Rescue** **Position: Full-Time Firefighter/EMT**

Guadalupe County Fire Rescue is accepting applications for the **Full-Time Firefighter/EMT position**. Interested individuals must submit a completed application along with supporting documents.

Position Summary:

Under general supervision, the Firefighter/EMT-B is responsible for controlling and extinguishing fires, conducting search and rescue operations, and responding to medical emergencies. This role includes administering life-saving measures, treating patients, operating various fire apparatus and emergency vehicles, assisting in fire investigations, participating in training and equipment testing, and maintaining accurate records and reports.

Probationary Period:

This position includes a **one (1) year probationary period**, during which the Probationary Firefighter will be evaluated on performance and skill by their Fire Apparatus Operator (FAO), Company Officer, and the Fire Chief. Additional testing may be required upon completion of the probationary period.

CERTIFICATES AND REQUIREMENTS

Minimum Requirements:

- Applicants must meet all minimum qualifications and attach copies of all certifications with their application.
- Texas EMT-Basic Certification (Texas Department of State Health Services)
- Basic Structural Firefighter Certification (Texas Commission on Fire Protection)
- Traffic Incident Management Program and Courage to Be Safe Program
- NIMS ICS Certifications: ICS 100, 200, 700, and 800
- Valid Texas Driver's License with the ability to obtain a Class B Exempt License within 180 days (6 months) of hire

Preferred Certifications:

- Driver/Operator Certification (Texas Commission on Fire Protection)
- Instructor I Certification (Texas Commission on Fire Protection)
- Swift Water Rescue Certification
- Basic Wildland Firefighter Certification (Texas Commission on Fire Protection or NWCG S-130/S-190)

Annual Minimum Salary: \$19.72 Hourly / \$65,100 Annually
