## **Guadalupe County to Host Bulk Clean-up Event**

GUADALUPE COUNTY, TX –Guadalupe County is reminding residents to participate in the Bulk Clean-up Event scheduled for Saturday, May 17, from 7:30 to 11:30 AM at the Road & Bridge Department, centrally located at 310 IH 10 West Frontage Road, near North Guadalupe Street in Seguin. This is a vital opportunity for residents to help maintain a safer and healthier environment.

Cleanup efforts reduce debris that can clog storm drains and waterways, allowing for proper runoff during heavy rains and minimizing the risk of flooding. Residents are also encouraged to eliminate any standing water on their properties, such as in buckets, tires, or containers, to help prevent the breeding of mosquitoes, which can pose a health risk during warmer months.

County officials remind residents that illegal dumping is a crime that negatively affects our neighborhoods and places an unnecessary financial burden on taxpayers. Keeping our county clean is a shared responsibility, and everyone can contribute by properly disposing of waste.

**Traffic Flow:** All vehicles must enter from North Austin Street and turn onto North Guadalupe Street, which is 0.5 mile north of IH-10. Vehicles will be guided to the Road & Bridge Central Yard to the proper disposal area and then directed to exit onto the IH-10 Frontage Road.

Residents must present a photo ID or utility bill to demonstrate their residency in Guadalupe County. The maximum trailer length permitted is 12 feet. Dump trailers and commercial disposal are not allowed. ## **ACCEPTED ITEMS**

- Trash (paper, plastics)
- Junk debris
- Furniture (sofas, tables mattresses, etc.)
- Household appliances (stoves, washers, dryers, dishwashers)
- Scrap metal
- Scrap tires less than 19.5" (without rims) Limit 4. No rims attached.
  Tires must be separated from other bulk items & visible for quick removal.
- Dry paint

- Bagged yard waste
- Ceramic toilets must be in a cardboard box
- Refrigerators and freezers must be empty, and the compressor and freon must be removed

## **NOT ACCEPTED**

- Hazardous Materials or chemicals (gasoline, used oil, liquid paints, acids, bases, anti-freeze, etc.)
- Batteries (Lead, NiCd, Lithium)
- Brush/Limbs
- Fencing
- Sheds
- Construction material & debris (asphalt shingles, insulation, sheetrock, etc)
- Dead livestock/pets
- Junk vehicles, boats
- Oil-based paint
- No dump trailers
- No gas in mowers or equipment
