



4. The only persons that have filed an application to have their name placed on the ballot are Bernard Mueller and Michael Andrews.
5. Two (2) positions for the office of director are scheduled to be voted on at the May 2, 2026 Directors Election, and only two (2) persons have filed an application to have their name placed on the ballot; therefore, only two (2) candidate's names would be placed on the ballot, representing two (2) candidates for two (2) positions available.
6. No person has filed a declaration of write-in candidacy for the May 2, 2026 Directors Election; therefore, no candidate's name is to be placed on a list of write-in candidates for the office of director.
7. Candidates Bernard Mueller and Michael Andrews are unopposed for election to the office of director.
8. The Board desires to cancel the May 2, 2026 Directors Election and authorize the posting of the Order of Cancellation attached to this Order as Exhibit B at each polling place that would have been used in the Directors Election.

**IT IS THEREFORE FOUND, DECLARED, AND SO ORDERED** by the Board of Directors of Springs Hill Special Utility District that:

- (i) the above Directors Election was duly called;
- (ii) the Secretary of the District has duly certified in writing that Bernard Mueller and Michael Andrews are unopposed for election to the office of director in accordance with law;
- (iii) Bernard Mueller and Michael Andrews are declared elected to serve a three-year term on the Board of Directors of said District, subject to taking their oath and executing and filing their bond as required by law;
- (iv) the Directors Election called for May 2, 2026, will not be held; and
- (v) a copy of the Order declaring the candidate elected, provide as Exhibit B, shall be posted in English and Spanish within the appropriate polling places established by Guadalupe County and the District on May 2, 2026.

It is further found and determined that notice of the date, place, and subject of this meeting was posted in accordance with the terms and provisions of Chapter 551 of the Texas Government Code at least 72 hours preceding the scheduled time of this meeting and that the terms and provisions of said Chapter 551 of the Texas Government Code have been complied with.

The above order being read, it was moved and seconded that the same do pass. Thereupon the question being called for, the following members of the Board of Directors voted:
